- 2. Margins: 2 cm on all sides.
- 3. Figures and diagrams should be created using *Microsoft Graph* (a Microsoft Word add-in). Please use shades of **black and white only** (patterns and hatchings may be added to improve readability).

#### The abstract must include:

- A description of the research problem under investigation;
- The **research methodology** used;
- The **main findings and conclusions** derived from the research.

- 10. Article title, author's name and surname, academic rank, position, and institutional affiliation presented in both Ukrainian and English.

#### Formatting guidelines:

- 1. Font: Times New Roman, size 12, line spacing 1.5.
- 2. Margins: 2 cm on all sides.
- 3. Figures and charts must be created using Microsoft Graph (add-in for Microsoft Word). Please use grayscale only (from black to white), and apply hatching or patterns for clarity when needed.

- Bibliographic entries must be formatted according to the Ukrainian National Standard DSTU 8302:2015 *Bibliographic Reference*. *General Terms and Compilation Rules* (Kyiv, 2016, 16 pages). <u>Link to standard (in Ukrainian)</u>

# REQUIREMENTS FOR SUBMITTING ARTICLES TO ACADEMIC JOURNAL *Ukrainian Socium*

Articles are accepted in **Ukrainian or English** and must be submitted as **Microsoft Word files**.

- 1. **UDC code** (top left corner, before the author's name).
- 2. **Author information** (in both Ukrainian and English): full name (surname, first name, patronymic), academic degree, academic title, position, institutional affiliation, institutional address, email address, and ORCID and/or Web of Science Researcher ID and/or Scopus Author ID (if available).
- 3. **Title of the article** (in both Ukrainian and English).
- 4. **Extended abstract** (in both Ukrainian and English), at least 1800 characters (excluding spaces), including keywords.
- 5. **Keywords** (in both Ukrainian and English).
- 6. Article structure, including:
  - o clear formulation of the research problem;
  - o review of recent research and publications;
  - o identification of previously unresolved aspects of the general problem;
  - o statement of the research aims and objectives;
  - presentation of the main content and justification of the results, highlighting key findings and novelty;
  - conclusions and prospects for further research.
- 7. **References list** (in the original language of the sources).

### Formatting guidelines:

- 1. Font: *Times New Roman*, size 14, line spacing 1.5.
- 2. Margins: 2 cm on all sides.
- 3. Length: 16–20 pages (approximately 40,000 characters).
- 4. All **graphic materials** must be clear and suitable for black-and-white printing. Graphics must be submitted as separate Excel files. Scanned images or those taken from the internet and inserted into Word documents will not be accepted, as they are unsuitable for professional printing.
- 5. **Figures and tables** must include titles and sequential numbering.
- 6. **Footnotes** or explanations should be placed directly below the tables. Sources must be indicated ("compiled from [source]" or "author's own elaboration").
- 7. All tables and figures must be explicitly referenced in the main text before their appearance.

#### **References:**

- The list of references must be presented in the order of their citation in the text, formatted according to the Ukrainian National Standard DSTU 8302:2015: Bibliographic References. General Provisions and Compilation Rules. <a href="http://lib.pu.if.ua/files/dstu-8302-2015.pdf">http://lib.pu.if.ua/files/dstu-8302-2015.pdf</a>
- A separate References section must contain English translations of the same sources formatted according to the APA (2010) international bibliographic style.
- Ukrainian names and titles should be transliterated using the official Cabinet of Ministers of Ukraine Resolution No. 55 (January 27, 2010) on the transliteration of the Ukrainian alphabet into Latin characters.
- At the end of each translated Ukrainian-language source, include the label [in Ukrainian] without a period.

Articles submitted without meeting these editorial requirements will not be considered.

### ARTICLES SUBMITTED FOR REVIEW MUST CONTAIN THE FOLLOWING STRUCTURAL ELEMENTS:

- 1. **Problem statement** in general terms and its connection with important scientific or practical issues.
- 2. **Review of recent studies and publications** that have addressed the problem and on which the author builds; identification of the previously unresolved aspects of the problem that the article focuses on.
- 3. Statement of the article's objective.
- 4. **Presentation of the main research material**, with full justification of the obtained scientific results.
- 5. **Conclusions** from the research and prospects for further investigation in the chosen field.



All submissions, **except for reviews and informational notices**, are subject to **double-blind peer review** (the reviewer does not know the author's identity, and the author does not know the reviewer's identity), carried out by members of the editorial board who are experts in the relevant field.

The peer-review process may take between 4 to 8 weeks.
